

#### NHAAC – November 2012

The last National Harbour Authority Advisory Committee (NHAAC) meeting was held in St. John's, Newfoundland and Labrador, November 21-23, 2012. Small Craft Harbours (SCH) Newfoundland Region did a great job of hosting this three-day meeting, as well as organizing a very informative, full-day harbour tour.

In his opening remarks, Michael Alexander, Regional Director General, Newfoundland and Labrador Region, acknowledged the collective contributions of the NHAAC and the SCH Program and commended Harbour Authorities (HA) for the contribution they make in providing services to harbour users.

During the meeting a variety of interesting topics were discussed. Micheline Leduc, Director General, SCH, and Chair of the NHAAC, opened the meeting by providing a status update of various ongoing SCH topics, including: the Harbour Authority Manual; transition to the Canada *Not-for-Profit Corporations Act*; engineering and environmental initiatives; the SCH financial situation and the Evaluation of the SCH Program being undertaken by Fisheries and Ocean's Evaluation Branch.

Other discussion topics over the two days included:

- The Compendium of Funding Sources;
- Regional Harbour Authority Advisory Committee Updates;
- Abandoned and Derelict Vessels; and
- An interactive discussion on the current changing environment that is affecting the fishing industry.

The meeting concluded with a full-day harbour tour of four harbours on the Avalon Peninsula, Newfoundland. The group had the pleasure of visiting and meeting with the Harbour Authorities from Port de Grave, Ochre Pit Cove, Bay de Verde and Old Perlican.


