The Tofino-Ucluelet airport advisory is very appreciative of your time and response to our inquiry regarding Westjet's long-term development goals for Vancouver Island. This information is very useful as the Advisory considers priorities for expansion of services at the Tofino-Ucluelet airport.

**RECOMMENDATION(S):**

1. **THAT** Council receives this report for information.
2. **THAT** Council direct staff to pursue installation of delineators and discs on Matterson Drive.

**PURPOSE:**

The purpose of this report is to provide Council with a recommendation to install delineators and discs along the Matterson Drive walkway between Peninsula Road and Bay Street.

**BACKGROUND:**

Council expressed concerns about the safety of the pedestrian along the walkway on Matterson Drive from the high school to Big Beach. Staff reviewed the area and recommended the installation of high visibility delineators and discs which will improve pedestrian safety.

The area will require 85 delineators and 150 discs at an estimated cost of \$14,500.00

**SUMMARY AND CONCLUSION:**

The objective of this report is to recommend the purchase of 85 delineators and 150 discs at a cost estimate of \$14,500.00. The total cost estimate does not exceed the allocated \$ 15,000.00 already budgeted for in 2014.

**RECOMMENDATION(S):**

1. **THAT** Council receives this report for information.
2. **THAT** Council direct staff to proceed with the purchase of four solar powered beacons for the gateway signs installed along Peninsula.

**PURPOSE:**

The purpose of this report is to provide Council with information on solar power flashing beacons.

**BACKGROUND:**

This year staff have installed new traffic signage along Peninsula Road and Matterson Drive as part of reducing speed within the school zone area. The new signage consisted of four gateway signs and nine playground zone signs changing the school zone area to a playground zone which enforces 30 km/h speeds from dawn to dusk.

It was requested that staff look at installing solar power beacons to the gateway signage to further improve on the speed reduction within the area.

Four solar powered beacons will be required at a cost of approximately \$2000.00 each for a total of \$8000.00.

The current budget does not have the sufficient funds however staff intend to utilize funds from the ICBC traffic control review budgeted in 2014.

**SUMMARY AND CONCLUSION:**

Staff seek Council approval to purchase four solar power beacons at a cost of approximately \$8000.00 utilizing the funds from the ICBC traffic control review from the 2014 Budget.
