 - 7.1 Overview of Municipal Budgeting

Donna Monteith, Director of Finance

- CAO Mark Boysen provided an overview of the budget meeting process going forward.
- Donna Monteith, Director of Finance, presented a PowerPoint presentation titled "2019 Preliminary Budget Planning", highlights included:
 - Legislated requirement to prepare a five year financial plan annually.
 - Preliminary goal is no more than a 3% tax increase.
 - Use of fund accounting focusing on accountability.
 - o Revenue sources for the municipality.
 - Reviewed objectives that will need to be included in the financial plan bylaw for surplus funds, reserve funds, tax allocation to classes, permissive tax exemptions, and development cost charges.
 - General operating funds cover all municipal services except for water and sewer.
 - Water and sewer operating funds look after the maintenance and distribution of the service.
 - Capital funds include general, water, sewer, and statutory reserves.
- Staff addressed Council's questions on the following:
 - Clarified that storm water is covered under the sewer funds.
 - Described different types of transfers.
 - How development cost charges are calculated.
 - Difference between statutory and non-statutory reserve funds.

7.2 Overview of Projects Mark Boysen, Chief Administrative Officer

- CAO Mark Boysen presented on some initial 2019 projects as well as 2018 projects being carried over.
- District will be setting more realistic timelines on what projects can be accomplished with current staff and capacity.
- List of RMI funded projects for 2019 will come forward in January.
- Council will need to discuss what to do with the Barkley Community Forest Funds.
- There will be more discussions on projects in January meetings with the goal of seeking early approval, so the projects can get started.
- Urban Systems has a contract to assist the District with project prioritization and includes ranking projects based on criteria.
- District has been offered community sirens from the City of Port

- Alberni. Staff are looking to identify the correct locations.
- Requested early budget approval for the installation of 2 crosswalks with street lighting, flashing crossing lights and signage. ICBC will be paying for 50% of the cost.
- Staff addressed Council's questions on the following:
 - Plans for the health centre: Meeting with Island Health staff being established for January and \$30,000 budget for 2019.
 - Crosswalks and safety in the area of Springs Cove.
