1.1 Mayor St. Jacques called the public hearing to order at 7:01 pm.

2.1 Mayor St. Jacques explained that the purpose of a Public Hearing is to hear representations from persons who deem their interest in property affected by the bylaws, as outlined in the Notices of the Public Hearing. 2. At a Public Hearing all persons who deem their interest in property affected by the proposed bylaws shall be afforded an opportunity to be heard on matters contained in the bylaw.
3. The Council may give such effect, as it deems fit, to representations made at a Public Hearing, in the bylaws as adopted.
4. At a Public Hearing the Council is under no obligation to enter into a debate on any issue. The purpose of a hearing is to hear representations, which will later be considered by the Council in the meeting.

Mr. Greig stated that in general terms the purpose of the proposed bylaw is to amend the CD-2B Subzone to reorganize the principle and secondary uses and densities to reflect that Lot 1 Plan VIP85870 will not be consolidated with Lot 12 Plan VIP84686, and to amend section 505.1 to isolate the staff housing parking requirement to 1 space per staff housing unit – defined as one bedroom as staff housing.

Mr. Greig noted that the applicant is also asking for a variance, Development Variance Permit DVP18-02, to reduce the required parking space setback from 3m to 1.5m from the lot line. The hearing is also an opportunity for the public to be heard by Council in regards to this development variance permit.





***TOQUAHT NATION RECEIVES \$400K INVESTMENT IN NEW SECRET BEACH MARINA***

COURTENAY – The Toquaht Nation is set to begin construction of a new \$1.35M marina development at Secret Beach and the Island Coastal Economic Trust is supporting the project with a \$400,000 investment.

The project includes the construction of 40-slip marina, construction of a new double-wide boat launching ramp, a new marina access road, parking facilities, and breakwater at Secret Beach.

The Marina is the first phase of a broader plan that will transform Secret Beach into a regional tourism hub. Future developments will include the construction of a common building with café, gift shop and meeting rooms, rental cabins, kayak comfort station and other infrastructure to support cultural tourism.

In conjunction with the future replacement of the marina at Toquaht Bay, there will ultimately be slips for 80 boats in the two nearby locations, with access to campgrounds and other services for the growing number of visitors to the region.

“The Toquaht Nation has been proactive and innovative in building new economic opportunities, and when environmental concerns forced a change in their plans to redevelop the Toquaht Bay campground and marina, the Nation identified a new opportunity at Secret Beach,” explained ICET Chair Phil Kent. “This project will attract visiting boaters to the islands and coastline of this rugged area creating new opportunities for eco-tourism, cultural tourism and hospitality business development.”

The region is a key access point for visitors to explore the Broken Group of islands between Bamfield and Ucluelet on the west coast of Vancouver Island. The Secret Beach Marina will provide safe harbour for those arriving by water and a safe access route for those arriving by land.

“My father – Chief Bert Mack – spent decades fishing in Barkley Sound, and I know he would be proud to see this new marina at Secret Beach,” said the Toquaht Nation’s Chief Anne Mack. “Our economic development mission is to create businesses that respect the history, culture, and traditions of the Toquaht Nation, and this project embodies that mission exactly.”

The Broken Group is a prime destination, particularly for the growing kayak tourism market. The islands, which number more than 100 uninhabited islands, is often described as 'dream destination' for paddlers. The routes are part of the new BC Marine Trails network - another project which has benefitted from ICET investment.

"Congratulations to Toquaht Nation and the Island Coastal Economic Trust on a partnership that will support Toquaht's continued success as a tourist destination on the west coast of the Island, said Scott Fraser, Minister of Indigenous Relations and Reconciliation and MLA for Mid Island-Pacific Rim. "This investment will drive new economic opportunities and create jobs for the Toquaht community, to the benefit of the entire region."

The project is expected to create approximately 3.0 person-years of new construction phase jobs as well as 15 permanent local jobs within a 3-5 year term.

I am encouraged by your respective resistances to local regulation changes that can promote increased use of this drug.

It would seem appropriate to ask anyone applying to open a store/dispensary a few questions: as for example, is he/she a pharmacist, does he/she have any medical training or experience in nursing or medicine, and also does the applicant have something to gain by getting your approval. Any suggestion of a possible conflict of interest would certainly invite questions about the validity of some of the claims and offers made.

I did some basic research and will forward a link to one as a starter.

We will hear the argument that, since marijuana is widely available in the community, it needs some supervision and control. That may sound reasonable, but clearly, to me at least, that should be someone who would have no personal gain from the operation.

I also am sceptical about the claim that, since it is widely used we need to except it as it is.

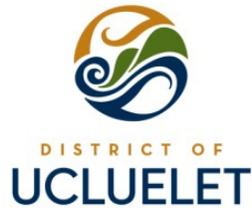

**RECOMMENDATION(S):**

**THAT** Council;

1. Review the Grant in Aid applications and award assistance based on the criteria outlined in the policy and attached schedule; and
2. Approve funding applications for Council contribution requests for facility use and lease payments as outlined in the attached schedule.

**PURPOSE/DESIRED OUTCOME:**

The purpose of this report is to seek approval from Council as to the recipients and the amounts to be awarded under the current Grant in Aid Policy as well as the Council contributions related to facility use and lease payments.

**STRATEGIC GOAL:**

This report is in response to the corporate objective of fiscal responsibility as identified in the current strategic plan.

**BACKGROUND:**

Legislation provides that Council may grant aid for or to a variety of organizations.

The prime purpose for the grant-in-aid is to provide one-time financial assistance to a non-profit organization for a specific project. Aid is to be considered on a year to year basis and continued support is not to be anticipated by any organization.

**Policy Criteria:**

1. Must provide a social enrichment service to the District.
2. Must be local in nature, in that the grant is for a specific service to the residents of the District.
3. The organization must be non-profit and provide a budget for its operation noting other funding sources and state specifically the grant request from the District.
4. The organization will submit a report after the grant has been received showing how the funds were expended.
5. Money will NOT be granted to a subsidized or commercial organization.
6. The organization must demonstrate that the service provided fills a need in the community and that there is no overlapping service already existing.
7. Grants will NOT be provided for sports organizations for competition or travel expenses.

**RECOMMENDATIONS:**

I recommend that Council approve grants in aid based on the criteria as outlined in the policy, and since the Junior Canadian Rangers did not meet the criteria, that their application automatically be denied.

Further, that Council support the USS Scholarship \$500, Discretionary funds \$500 and School trip funds \$1000 through an annual line item within the Council Contributions budget. Criteria for the discretionary funds should be outlined through a Council Policy.

Council Contributions for facility use be considered as per the attached schedule and that direction be given to the Chief Financial Officer as which applications are approved.

**FINANCIAL IMPACTS:**

Currently there is \$20,000 within the Grant-in-Aid budget to be used as per the policy and at Council's discretion. And there is \$47,648 in the Council Contributions budget for the Organizations listed.
